


Comments

The One Community-One Child Program is a parent involvement initiative funded by the 75th Legislature (1997). Since that time, with the exception of fiscal year 2003 during which the program was inactive, One Community-One Child has provided support through the Region 10 Education Service Center (ESC 10) to schools in Dallas ISD, Wilmer-Hutchins ISD, Cedar Hill ISD, DeSoto ISD, Duncanville ISD, Grand Prairie ISD, Irving ISD, and Lancaster ISD to encourage parents to become actively involved in their children's educational experiences. The funds provide stipends to parents who cannot take unpaid time away from jobs, non-monetary incentives to non-working parents to perform volunteer activities, information packets to parents, programs to reward parental participation, and development of parent centers in the schools. For working parents who cannot arrange time off without loss of income, the principal or school project coordinator will contact the parents' employers requesting special consideration. There is no indication that this program will continue past the 2003-04 school year.

Evaluation*

No external evaluations have been conducted for this program. However, ESC 10 performs internal program evaluations. The evaluations cover the following topics: Efficiency, Effectiveness, and Economy (positive rating from 87.5 percent of the respondents); Support of State Initiatives (positive rating from 50.0 percent of the respondents); Depth and Breadth of Knowledge of Consultants (positive rating of 75.0 percent of the respondents); Effectiveness of Communication (positive rating of 70.0 percent of the respondents); and Improvement of Teacher, Staff, and Administrator Quality (positive rating of 83.3 percent of the respondents).

In most cases it is not possible to isolate the effects of funding for a single program on students' performance because districts applying for state funding for at-risk students are required to combine local, state, and federal resources to maximize services to at-risk students. For the same reason, a single program's cost does not provide a meaningful basis for determining the cost per student of a desired or achieved outcome.
